## **Contract of Employment**

**Between the Employer, MINI MART ONE LTD**

**205 East India Dock Road ,Manny News ,London ,E14 0ED ,United Kingdom**

**and the Employee, AKTHER HOSSION**

**15A ,Shrubbery road ,LONDON ,SW16 2AS ,United Kingdom**

### **Start of Employment and Duration of Contract**

The employment will start on 01/03/2023 and the Initial duration of work is a 3 year period. This contract may be extended in future subject to your performance and subject to immigration control if it is required for your visa condition.

### **Probationary Period**

The employment is subject to the completion of a 3months probationary period.

If, at the end of the probationary period, the Employee's performance is considered to be of a satisfactory standard, the appointment will be made permanent.

During the probationary period, one-week's notice may be given by either party to terminate this contract.

In lieu of notice during the probationary period, the Employer may pay the Employee the salary that he would have earned till the end of probationary period.

### **Job Description**

The Employee is engaged initially to perform the duties of SHOP MANAGER

- Overseeing business finance and managing the budget along with controlling security arrangement for the premises
- Recruiting staffs as per business needs
- Establishing policy for the staffs and ensuring that the policies are being followed appropriately.
- Training staffs adequately to make sure they are properly trained for the role.
- Report any change directly to the director.
- Examine quality of supplies and ensuring they are being effectively used.
- Communicate with customer service department to provide merchandise and promotional offer information to the customer.
- Ensuring customers queries are handled effectively.

The Employee will, however, be expected to carry out any other reasonable duties in line with his responsibilities to assist in the smooth operation of the business.

## **Qualifications**

If the Employee's employment with the Employer is dependent upon the possession of particular qualifications or registration with a statutory Body or other Authority, then evidence of this must be produced on request.

Failure to produce such evidence may lead to the termination of the employment.

## **Place of Work**

The normal place of work will be at the Employer's address shown above.

Following reasonable notice and consultation, however, the Employee would be expected to work at any other premises if required.

## **Working Hours**

The working hours are 39 per week.

The Employer may require the Employee to vary the pattern of his working hours to meet the needs of the service.

The Employee's entitlement to have paid refreshment breaks.

## **Remuneration**

You are entitled to be paid GBP 26000 per ANNUM . Your salary will be paid by BACS .

Your rate of pay will be reviewed in every six months. Your rate of pay will not necessarily increase as a result of the review.

## **Overtime payments**

Additional payments will be made for overtime worked as per company policy.

## Holidays

The Management's holiday year runs from 1st January to 31st December inclusive. If you work part time your pro-rata entitlement will be based on the number of hours you work. If you work as a full time employee you will be entitled to have 28 days paid holiday in each year, in addition to statutory holidays. You are allowed to take an unpaid holiday subject to special circumstances, but it must be prior approved by the management.

You must obtain authorization from the Management before making any holiday arrangements. The date of holidays must be agreed with the Employer and a Holiday Request must be completed and authorized by the Employer at least 14 days prior to your proposed holiday dates. **Any unauthorized absence for more than 10 days will be notified to the Home Office UKVI if it is required for your visa condition.** Furthermore, disciplinary action may be taken against you. You must inform the management immediately if there is any change of circumstance, such as change of contact details, change of your immigration status etc.

## Sickness

Subject to you complying with the above notification and certification requirements, plus any additional rules introduced from time to time, you will, if eligible, be paid Statutory Sick Pay in accordance with the legislation applying from time to time.

For the purpose of Statutory Sick Pay, your qualifying days are Monday to Friday.

The Employer does not operate a sick pay scheme other than Statutory Sick Pay.

## Pension Scheme

To support individuals in saving for retirement, the government mandates employers to offer a workplace pension scheme known as "pension automatic enrolment" (PAE). Within three months of starting employment and meeting specific age and earnings criteria, you will be automatically enrolled with our chosen pension provider. Through the company's salary sacrifice (known as SMART) scheme, a portion of your salary will be directed towards your pension. The terms for accessing your pension funds will be determined by the pension provider. More information about the pension scheme will be provided once you join the company. While you have the option to opt out of the pension scheme, this can only be done after automatic enrollment. If you opt out, you won't be able to rejoin for 12 months, but you'll have the opportunity to enroll again after that period. Additionally, every three years, eligible employees will be re-enrolled into the pension scheme, even if they previously opted out.

## Notice of Termination

Where there is just cause for termination, the Employer may terminate the Employee's employment without notice, as permitted by law.

The Employee and the Employer agree that reasonable and sufficient notice of termination of employment by the Employer is the greater of four (4) weeks or any minimum notice required by law..

## **Redundancy**

If the Employer decides to reduce manning levels, suitable volunteers will be asked for.

In addition, the Employer may select other employees for redundancy on the basis of an assessment of relative capabilities, performance, service length, conduct, reliability, attendance record and suitability for the remaining work.

In the event of redundancy, statutory redundancy terms will apply.

## **Rules of Conduct**

The Employee must:

- not endanger the health or safety of any employee whilst at work;;
- at all times use as instructed any protective clothing or equipment which has been issued;
- immediately report accidents, no matter how slight;
- observe all rules concerning smoking and fire hazards;
- act wholeheartedly in the interests of the Employer at all times;
- acquaint (himself/herself) with all authorised notices displayed at his place of work;
- inform the Employer if he contracts a contagious illness;
- not remove any material or equipment from his place of work without prior permission;
- not use the Employer's time, material or equipment for unauthorised work;
- at all times follow Employer's working and operation procedures.

## **Misconduct Leading to Summary Dismissal Without Notice**

- theft of the Employer's property;
- fighting, physical assault or dangerous horseplay;
- failure to carry out a direct instruction from a superior during working hours;
- use of bad language or aggressive behavior on the Employer's premises or in front of customers;
- wilful and/or deliberate damage of the Employer's property;
- incapability through alcohol or illegal drugs;
- loss of driving licence where driving is an essential part of the job;
- endangering the health or safety of another person at the place of work;
- deliberately falsifying the Employer's records;
- receiving bribes to affect the placing of business with a supplier of goods or services;
- falsely claiming to be sick in order to defraud the Employer;
- immoral conduct.

## **Disciplinary Action**

Should the need for disciplinary action be deemed necessary, this will be taken in accordance with the Employer's Policy and Procedure on Disciplinary Action.

## Grievances

Where the Employee has a grievance relating to any aspect of their employment, they should contact their immediate manager and give full details of his grievance, in confidence.

The Employee should allow reasonable time for consideration of all the facts before remedial action can be taken.

Where the Employee's immediate manager is not able satisfactorily to resolve the grievance, the Employee should refer the matter in writing to the most senior manager available.

The Employee has the right to be accompanied by a work colleague or by another person as in accordance with the current legislation throughout the grievance procedure.
